- 1. Safety & Values Share
 - Great job! Due to quick communication between FPM employee Luis Corona and EH&S, FPM was able to provide follow up with USC restaurant managers regarding corrosive material related to an eyewash station. The issue was mitigated on the spot.
 - Thank you to Mark, and his team. The trench drains by RTH will be permanently affixed this week.
- 2. Friendly Reminders
 - A friendly reminder for all employees to wear the required surgical or N95 when working on USC sites and buildings.
 - Please be extra cautious when driving. Defensive driving is very important as we start coming back to campus and more people are now on the road.
 - Action item- Safety Team to take the 15-minute IIPP training through Trojan Learn before our next meeting.
 - Action Item- Gary will reach out to Travis Tyler to follow up on the ZBI sprinkler. It was a safety concern reported by Blake that this sprinkler needs a protective cover.
- 3. Committee Successor Seats- follow up
 - A final candidate has not been identified yet to fill Ed Parra's seat, but Eric will provide an update next month.
 - Mark will reach out for an Engineering representative.
 - Shane will reach out for a Zones representative.
- 4. New Employee Safety Orientation
 - The FPM Trojan Learn eLearning module curricula is in the final development stage. Gary and his team will send out a first look to the Committee this month.
- 5. Injuries & Reporting (Gary & Ana)
 - FPM had a minor first aid incident in December 2021 which was reported within the FPM timeframe guidelines.
- 6. Progress update (Gary, Jose & Bianca)
 - Cart Safety Training- Gary and his team have partnered with EH&S on a "Train the Trainer" cart safety program. Both Auxiliaries and Housing will also be a part of this program. FPM Outreach will be coming in February to train Bianca, Jose, and the Landscape group.
 - The FPM Safety Training Matrix will be ready at the end of Jan. A working draft will be shared with the committee for feedback.



- The FPM IIPP Injury Illness Protection Program has been updated and finalized. A draft will be shared with the Safety Committee to provide input at our next meeting.
- Veoci Training will take place this Thursday 1/20. Quarterly trainings will be set up going forward to include practical training for emergency response. Veoci will be one of our tools in our virtual toolbox.
- 7. Construction Safety Update (Group)-
 - The (CSM) Contractor Safety Management program draft was submitted to both Risk Management & Procurement for comment. This new structure allows flexibility with contractors and vendors who provide USC with 3rd party services. The Committee will receive a draft later this month for review.
- 8. Roundtable
 - The air handler at Health Science Campus- CSC 116 is currently down. A temporary unit was installed indoors. However, the power cord has presented a tripping hazard in this area. The heat load in room 116 is greater than what is required so the air handler will need to remain in the building.

• Action Item-Eric will find out who placed the air handling unit in the building and assign someone to secure the cord.

• The (SOP) Standard Operation Procedures for fire extinguisher residual clean up and disposal method has been updated. FPM Safety is currently working with Hazmat on all non-fire related discharges. The SOP will be available in both English and Spanish.
